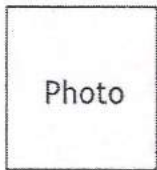

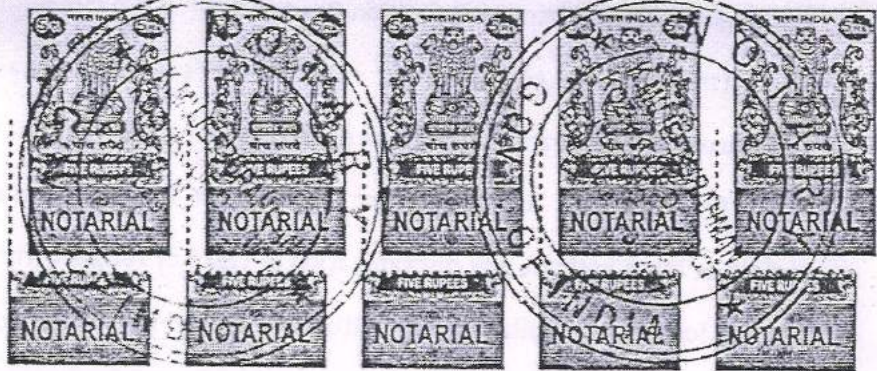

A charitable trust named "Islamic welfare Trust-Omassery (IWTO)" was formed orally on 10<sup>th</sup> January 1980 with Rs.500/- as donation and capital assessed as Rs.1000/- including property worth Rs.500/- in R.S.11/4 in puthur amsom Omassery desom of Kozhikode taluk. Later it was declared before Notary Public on 11<sup>th</sup> December 1980 and subsequently the trust was registered as "Islamic welfare Trust-Omassery (IWTO)" on 23.02.2011 valuing assets as Rs.1000/- before Kozhikode SRO as Document No.65 in 4-402-115-117 parts. Later as per the application approved by the trust Board Meeting on 15.01.2014 application for modification as per the Income Tax Act was made and proceedings of Income Tax Commissioner C.No.Tech/CIT-CLT/ADT-14/2013-14 dated 18.02.2014 permitted to make necessary amendments to the Trust. So it was decided to make the following amendments and as the Trust Chairman I have been empowered to sign and register the modification deed and it is the reason behind this Trust Modification Deed.

It is decided by this Trust Modification Deed that

I. The aims and objectives of "Islamic welfare Trust-Omassery (IWTO)" registered before Kozhikode SRO as 65/2011 is amended as follows.

- 1) To plan and implement schemes for the basic necessities of the society at large without any discrimination of caste or religion without any profit motive for social, cultural, agricultural and environmental activities giving preference to backward calamity-hit people and assure the integrity of the nation.
- 2) To undertake and manage educational ventures from nursery level to research in higher levels.
- 3) To build and give help for starting modern and technically advanced library and reading room for educational upliftment.
